The remaining balance of \$ (70%) will be due two weeks before the delivery date.</li> <li>Half of the 30% deposit is completely refundable within 60 days of the event.</li> <li>The 30% deposit is non-refundable within 60 days of the event</li> <li>No refund for the cost of the desserts is available two weeks prior to the event</li> <li>If Bondbons has to cancel in the case of an unforeseeable situation, 100% of the payment will be refunded</li> </ul>
2. Any changes to this order must be made at least four weeks prior to delivery. Client may make up to three changes for free and then a charge of \$25 per change will be charged after that.
3. If fresh flowers will be used with the arrangement, it is the responsibility of the florist to determine flower safety and safe food practices and not the caterer.
4. Ingredients or machinery may contain or come in contact with peanuts, tree nuts, milk, and wheat products.
5. In the case of an unavoidable situation, such as a car accident or poor road conditions during delivery, Bondbons cannot be held liable for more than the cost of the above ordered cake.
6. In the event that the caterer must seek legal remedies to complete execution of this contract, the client agrees to pay all reasonable attorney fees.
7. In the event that supplies of Bondbons were borrowed for the display the patrons will be liable for any damage or loss of any property by theft or otherwise caused by patrons, members, guests or invitees.
